AUTHOR GUIDELINES FOR PAPER SUBMISSION

Nepalese Journal of Business and Management Studies (NJBMS) is indexed in NepJol, plagiarism free and a peer-reviewed management journal published annually in April by the Management Research Department of Saraswati Multiple Campus. The journal seeks high quality research-based articles within its scope. The accepted paper for publication should not have been and be published anywhere without the permission of the Editorial Committee. However, the ideas and opinions expressed in the papers published in the Nepalese Journal of Business and Management Studies (NJBMS) will be of authors and in no way represent views and policies of the Management Research Department, Saraswati Multiple Campus and the Editorial Board. Authors submitting paper should comply with the following guidelines:

1. The journal only accepts the empirical or review-based research papers written in English in Times New Roman 12-point font size (except where stated), and full justification.
2. Manuscripts submitted to the journal must be the original work of the author's, must not have been submitted anywhere for publication, and not published in full in any other journals.
3. All submissions must include (a) a cover page that bears the title of the article, the author's name and affiliation, and an abstract (not more than 180 words) with at most 5 keywords. Likewise, at the end of the cover page, please include the name, address, phone numbers and email OF THE CORRESPONDING AUTHOR where your complimentary journal(s) should be mailed (b) main body (include heading levels 1, 2, 3 and 4) (c) acknowledgements (optional), references and appendices (if any).
4. All manuscripts must contain references, only for all the works cited in latest version APA style, and tables and figures should also be in accordance to APA style.
5. All manuscripts will be desk screened, assessed by blind reviewers, and finalized by editors (after the correction by the authors within the deadlines).
6. The journal does not charge its authors any fees for submitting and publishing their manuscripts as it is fully funded by the institution itself.
7. For any dispute regarding the manuscript for publication, the decision of the editorial board will be final. Authors should e-mail their manuscripts to:
