Submission Guidelines

DOSSMCTU establishes a guideline that must be followed by the authors while submitting their originals. Failure to comply with the guideline may imply the rejection of the Article.

Articles to be considered for publication must be rich in sociological theory, method and analysis.

Articles should be original and unpublished, and should be written only in English.

Articles received follow the double-blind peer review process.

The DOSSMCTU does not charge fee for submission of papers, nor does it charge fee for the publication of its articles.

Authors are required to provide their full name, institutional affiliation and current status, highest educational attainment, country, and email address.

All text (including footnotes & references) must be double spaced and in 12-point type.

Each article must have a title, abstract, and keywords, separated by semicolons, followed by introduction, methodology, literature/theoretical review, result/analysis/discussion, conclusion, sources of funding (if any), acknowledgements (if any), and references.

Abstracts length should have no more than 200 words, excluding the title, and three to five key words.

Length of the article ranges 6,000 to 10,000 words, including the title, abstract, keywords, and references. The SJS adheres to the publication standards of the latest ASA style manual.

Articles can be sent to the DOSSMCTU throughout the year.

Editorial Board of the Department has full authority to accept or reject the article.
